In the Venerable Nano Nagle's time (1718–1784), because of the penal laws, the Catholic Irish were denied political, economic, social and educational rights that would have lifted them from mass poverty. Filled with passion for life, Nano turned her energies toward educating Irish Catholic children who were refused schooling. She went from hovel to hovel each day to gather the neediest people to teach. Nano was known as "The Lady of the Lantern" for her nighttime ministries of bringing food, medicine and comfort to poverty-ridden elderly and sick. She devoted her life to lighting the way for those in need, transforming lives by offering hospitality, compassion, love and hope. Following in her footsteps, we carry the light of Nano's lantern forward, weaving the example of her life with our lives today.


